**Item 4. Non Action Items.**

**Report from the Charter Review Committee on their recommendations regarding the Scarborough Town Charter.** The following members of the Charter Review Committee were present: Annalee Rosenblatt – Chair, Kerry Corthell - Vice Chair, Jack Kelley, Len Higgins, Charles Callahan and Bud Hanson [Absent - Tinamarie Smith]. Christopher Vaniotis, Town Attorney was also present to respond to any questions there might be from either the Charter Committee or the Town Council.

A. Rosenblatt, Chair, gave an overview on the proposed changes being recommended by the Committee. She and committee members responded to questions from the Town Council. Mr. Vaniotis, Town Attorney, noted that depending on the changes being made, if there were changes similar – e.g. grammatical change – then these changes could be grouped into one question. There were a few members of Council whom felt that the Council should hold a workshop to discuss the changes in depth and what recommendations –if any – would go to the voters.

Mr. Vaniotis noted that it was ultimately the Council’s decision as to what would be sent to the voters and when. He would also review the recommendations and place them in a format that would or could be sent to the voters.

The Council then thanked the Committee for their time and work on the proposed recommendations.
